**Instructions for Contributions from a Corporation or Labor Organization
Supporting or Opposing a Ballot Issue
Form 30-B-1**

This form is used when a corporation or labor organization makes a contribution directly to a ballot issue or levy committee. This includes either monetary or in-kind contributions. This form is filed with the Secretary of State for statewide issues. If the ballot issue or levy is not statewide, then this form should be filed with the appropriate county board(s) of elections.

The corporation or labor organization is responsible for filing this form. This form should **not** be filed by a campaign committee, PAC, political contributing entity, legislative campaign fund or political party. If a corporate-sponsored or labor organization-sponsored PAC makes a contribution, the appropriate place to report that expenditure is the PAC report.

Filing Individual/Entity Information

Complete the section of the form that provides the name and address of corporation or labor organization that made the contribution.

Report Type and Election Date

Indicate the type of report being filed and the year in which the report is being filed. Also indicate the specific election date, if any, that the issue is on the ballot for which the contribution was made.

Contribution Information

Indicate the committee receiving the contribution. If the contribution was in-kind, a description of the item or service should be included in the appropriate space. If the contribution was monetary, cash or check should be indicated. Complete this information for each contribution made. If necessary, attach additional sheets.

Reporting Requirements

A **pre-election** filing is due by 4pm 12 days before an election if \$1,000 or more in contributions were made by the 20th day before the election.

A **post-election** filing is due by 4pm 38 days after the election if either:

1. Contributions were made totaling less than \$1,000 by the 20th day before the election and no pre-election filing was made; or

Any contributions were made between the 20th day before the election and the 31st day after the election.
