If there were no candidate filings for judge or clerk of a municipal court, please return the form indicating "none."

**NOTIFICATION OF ELECTION DATES**

Municipal charters may provide for election dates other than the statutory primary, general and special election dates. It is imperative we receive notification of **all** elections (including court ordered elections) held in your county on days other than the statutory election dates. Please notify our office in writing of these election dates and the purpose of the election within 10 days of the board's knowledge of the election. A copy of the absent voter's ballot must also be sent to the Secretary of State's office at least 25 days before the election in accordance with R.C. 3509.01.
