



Attention Ohio Voter

Every eligible Ohio voter can cast one vote. A voter who requested an absentee ballot and appears in person to vote may cast a provisional ballot on Election Day if that voter appears in person to vote at the polling location on Election Day.

If you received the application shown, or any other absentee ballot application and completed and submitted it to your board of elections, you are not eligible to cast a regular ballot at the polls today. However, you may cast a provisional ballot.

Your provisional ballot will be counted after the 10th day following the election pending the board of elections' determination that your voted absentee ballot was not returned and counted prior to the closing of the polls and you are an eligible voter.

- I understand that if I do not provide the board with all of the required information, my application cannot be processed.
- I hereby declare, under penalty of election falsification, that I am a qualified elector and the statements above are true.
