

Declaration of Candidacy and Choice for President of the United States Party Primary Election

For Delegate-At-Large or Alternate-At-Large to the National Convention (Several Candidates)

Only to be used by a candidate for president whose registered principal campaign committee treasurer has certified that the candidate has met the contribution requirements contained in Division (A) of Ohio Revised Code §3513.121. This group petition form may be submitted only by a group of candidates equal in number to the whole number of delegates-at-large or alternates-at-large to be elected who are designated by the presidential candidate as his/her approved delegates-at-large or alternates-at-large.

To be filed with the Secretary of State not later than 4 p.m. of the 90th day before the day of the presidential primary election.
