

# Declaration of Candidacy

## Party Primary Election

### For District Delegate or District Alternate to the National Convention

Only to be used by a candidate for president whose registered principal campaign committee treasurer has certified that the candidate has met the contribution requirements contained in Division (A) of Ohio Revised Code §3513.121.

To be filed with the Secretary of State not later than 4 p.m. of the 90<sup>th</sup> day before the day of the presidential primary election.
